

Guymon Pioneer Days Mercantile 2020 Information Sheet

Dates: Saturday & Sunday, August 22 & 23, 2020
Hours: Saturday, 10:00 am – 7:00 pm
Sunday, 11:00 am – 5:00 pm
Where: Texas County Activity Center, North 5th St. & Sunset Lane, Guymon, OK
Booth: Craft booth – 10' X 10' = \$90 each. Max of three (3) booth spaces for the first four (4) entries ONLY.
Commercial booth – 10' X 10' = \$125 each. Max of three (3) booth spaces for the first four (4) entries ONLY.

There will be a \$25 charge on ALL returned checks!

Assigned Space: Space is assigned by the Mercantile Chairpersons, following your request as closely as possible. **Exhibitor shall not assign, share or sublet any part of the space without written consent. All exhibitors are subject to approval and must stay inside allotted spaces. Remit full payment with this application!** Any leased space not occupied by 10:00 am on May 4, 2019, will be forfeited, unless prior arrangements have been made with the Mercantile Chairman. Mercantile Chairman may re-allot or sell such space immediately without further notice to exhibitor, with **no obligation for refund. Display must be completed by opening time. Construction is not allowed during show hours. Bring you happy face and happy disposition. IF NOT, PLEASE DON'T COME OR GO HOME!**

Set Up: Friday, August 21, 2020 – 4:00 pm - 8:30 pm
Saturday, August 22, 2020 – 8:00 am - 10:00 am
Before setting up, you will need to turn in your OK tax # OR your Social Security #.

Move Out: Move out time is 5:00 pm, Sunday, August 23, 2020 **no exceptions.** Early packing of a booth is prohibited. Anyone doing so **will not** be invited to return. It is the height of disrespect to even those last few attendees and unfair to exhibitors.

Parking: Short term parking near the Activity Center for **loading & unloading only.** When you are finished unloading, you will be required to move your vehicles back behind the first 3 rows in the parking lot. **Parking in front and near the Northeast doors are for loading and unloading ONLY. Pre-warning:** There will be horses, corrals and carnival all around the Activity Center while unloading and during the craft show; remember that they make messes.

Liability: Exhibitor **may not** hold the Guymon Chamber of Commerce, and any of its committee members, the Texas County Activity Center or Texas County **responsible in case of personal injury or damage to items on exhibit.**
