#### IX. Presentation: Northwest Domestic Crisis Services

Northwest Domestic Crisis Services have served the panhandle for over 20 years. The main office is located in Woodward; the Guymon office services Texas, Cimarron and Beaver Counties. Men, women and children are welcome – sixteen years of age with a child or 18 and older can receive individual services.

The facility has a 30-day shelter that is safe and secure. Fourteen people can reside in the facility, but they can take up to 20 in extreme circumstances.

Donations – clothing, furniture and household items – are accepted through donations. Groceries are provided through community support and fundraisers, i.e. 12 Days of Christmas.

Consumers receive training/education to help them live independently.

Rapid rehousing helps find and pay up to 75% of deposits on utilities.

NWDCS is governed by an eight-member volunteer board of directors. The board is currently searching for individuals to serve as an advisory committee.
